She went through various bouts of drinking and depression which culminated in a suicide attempt. Then she realised she could no longer participate in the murder of innocent children. conceived through rape

Some people believe that abortion is the solution to a pregnancy from rape.

For those babies, they'll make an exception.

I was conceived through rape. My name is Rebecca Kiessling
I am that exception.

Rape is a terrible offence. Naturally all decent people want to help and comfort rape victims. But what do we do when there's another innocent person involved? Should babies conceived through rape be punished for their fathers' crime?

When she was 18 years old, Rebecca learnt that her father was a serial rapist, and she was conceived through one of his brutal crimes. Rebecca's birth mother came under enormous pressure to abort her child, and had even looked into options of abortion through the illegal back alley abortion facilities of the time. But in the end she changed her mind, because she said that nothing is so precious as a baby, and maintained that her daughter deserved the same right to life as all other children, regardless of circumstances.

These are deeply personal matters but Rebecca has spoken publicly about them. That's because she knows that children conceived by rape have become utterly defenceless in a society that mistakenly believes abortion is the answer.
